1. CONFIDENTIAL INFORMATION & NON-COMPETE. Both parties agree not to disclose any proprietary or confidential product information (including, but not limited to, pricing information). Dealer will not copy, reverse-engineer, or re-design, or use as a template or model any Sledgebats product with the intent to re-produce, manufacture, distribute, or sell any copied products after termination of dealer status
2. PRICING. Dealer pricing is not available online. If the dealers price changes, email notification will be given to you at least 30 days in advance.
3. All Sledgebats are made to order to your requested size, color and grips. Special order colors can be done when 10 units or more are purchased with our stock color grips. 2 week additional manufacturing lead times are necessary for all custom colors at this time.
4. ORDERS. Dealer will agree to maintain a minimum purchase volume of US \$1,000 annually, with 6 bat minimum individual purchase orders. The dealer's initial order must be placed within 30 days of becoming a dealer. Direct shipping is available to your customers, a shipping charge will apply
5. Standard delivery and lead times are 15 days from order confirmation. All orders ship standard post U.S. Mail or UPS
6. PAYMENT. Payment will be made before all shipment of products. Custom colors require payment before production starts and is non refundable.
7. SHIPPING. All shipping is F.O.B. Sledgebats Corona, California U.S.A. Dealer is responsible for all shipping costs to any location when minimum purchased orders are not reached. Freight is pre-paid to dealer locations when minimum order requirements of 6 BATS are reached.
8. TERM & TERMINATION. Failure to meet the agreed terms of this agreement may result in the termination as an direct SLEDGEBATS dealer.
9. LIABILITY. SLEDGEBATS will not be responsible for any lawsuits caused by improper or unsafe use of any products purchased from SLEDGEBATS.
10. ASSIGNMENT. This agreement may not be assigned or transferred to any third party without prior written consent by SLEDGEBATS LLC.
